letter from the executive director and president

Dear friends,

We are pleased to provide you, our fellows, colleagues, and supporters, with SFP's 2008 Annual Report. Although 2008 was merely our fourth year of operation, much was accomplished. We are reminded of author Glenda Cloud's quote that "change is inevitable, growth is intentional." The SFP board and staff worked together in 2008 to grow the organization, our membership, and our internal capacity.

Research funding: 2008 represents the second year that SFP managed a Request for Proposals program and subsequently committed more than \$609,000 to researchers for large and pilot grants.

Annual Meeting: We convened our society's annual meeting in conjunction with Reproductive Health 2008 in September in Washington, DC—the fourth annual meeting that SFP has co-produced with our conference partners.

Publications: *Contraception*, a peer-reviewed scientific journal, is SFP's official journal. It is produced monthly and has consistently been the main source for the expansion of knowledge related to family planning for almost four decades.

Fellowship growth & development: In the past two years, our membership has more than doubled in size. In 2008, we created a new category of candidate fellowship to provide greater opportunity for academic leaders in our field to become members.

Operational infrastructure: In July of 2008, we relocated the SFP administrative office from San Francisco to Philadelphia, where we established an independent

office and the necessary administrative systems to advance our work and be positioned to incrementally grow the benefits of fellowship.

On behalf of the board of directors and staff, we want to thank our fellows, junior fellows and candidate fellows for becoming a part of our academic society—and for the incredible wealth of experience and leadership you provide to the field of family planning care and research. Indeed, our greatest strength is the collective expertise of the membership. IN SEPTEMBER, nearly 800 attendees gathered in Washington, DC, for *Reproductive Health 2008*, our society's fourth annual meeting. *Reproductive Health* is the preeminent conference on reproductive health and is sponsored jointly by the Association of Reproductive Health Professionals (ARHP), Planned Parenthood Federation of America (PPFA), and SFP.

PRE-CONFERENCE SESSIONS: As a special pre-conference session, SFP sponsored a panel for junior faculty on career development and research. SFP fellows and board members also helped lead a pre-conference session on understanding the scientific literature. Other pre-conference sessions covered promoting post-abortion well-being, incorporating reproductive environmental health tools into practice, long-acting reversible contraception, and advocating for hot button policy issues.

Conference sessions: During the main conference, SFP sponsored a "lunch and learn" session on balancing career and family. SFP members presented sessions on including sexual and reproductive health content in primary care professions training, male contraception, working with the Cochrane Prospective Meta-analysis Program, late-breaking reproductive health updates, and emerging issues in abortion care—as well as plenary sessions on translating the most frequently downloaded articles into clinical practice, strategies for reducing high unintended pregnancy and repeat abortion rates in the United States, a vignette-based approach to addressing hormonal contraception, the HPV vaccination, and contraception for obese women. SFP members also moderated sessions on cardiovascular risk factors in the postmenopausal woman, preconception and interconception care, teen pregnancy rates, and best-practice patient education materials.

2008 Annual Meeting

ABSTRACTS (ORAL & POSTER PRESENTATIONS): SFP provided leadership and significant fellowship participation in the scientific abstracts, which were presented in four separate sessions during the conference. Poster presentations were on display for two full days of the meeting.

AWARDS DINNER: Each year at Reproductive Health, SFP hosts a dinner for SFP members at which our two annual awards are announced. Our Lifetime Achievement Award, honoring individuals whose cumulative research has reached the highest level of importance in the field, was awarded this year to Sheldon Segal, PhD. Dr. Segal directed the research that led to the development of copper-bearing IUDs and implant contraceptives, as well as initial studies on contraceptive vaginal rings, the intrauterine system Mirena®, contraceptive vaccines, and male contraceptives. Our Allan Rosenfield Award for Lifetime Contributions to International Family

Planning, created in 2007 to pay homage to SFP founding Board member, Dr. Allan Rosenfield, by honoring individuals who have made invaluable contributions to the health of women worldwide, went to Dr. Paul Van Look. Dr. Van Look is Director of the Department of Reproductive Health and Research at the World Health Organization. He has traveled extensively in developing countries and has been an adviser to governments on a wide range of sexual and reproductive health issues.

In the fall of 2006, SFP had 78 fellows and junior fellows. By the end of calendar year 2008, we had grown to 170 qualified members, including 73 full fellows, 6 candidate fellows, and 91 junior fellows. The new category of candidate fellowship was created in 2008 to provide greater opportunity for academic leaders in our field to become members.




